Learn about your water quality through affordable, confidential testing and become empowered to make decisions about system maintenance and water treatment!

The goal of the Virginia Household Water Quality Program is to improve the water quality and health of Virginians with private water supplies, including wells, springs, and cisterns.

How does it work?

- Pick up a sample kit at the designated location for your county. (Physical distancing measures will be in place, and <u>masks are</u> <u>required</u>).
- 2. Participate in the live Kick-Off Session via Zoom.
- Collect samples on designated date, and drop them off at the designated location for your county. (Physical distancing measures will be in place, and <u>masks are required</u>).
- 4. Samples are analyzed at Virginia Tech.
- 5. Participate in the live Results Meeting via Zoom to help you

understand your results. Receive your confidential results and information about addressing any problems via mail or email.
