## Frederick County Public Schools Work-Based Learning Presentation

Emily Roy, Frederick County Public Schools employee, gave a presentation on an upcoming program to provide fresh produce to students. ELC members provided Emily with positive comments and suggestions and voiced some concerns for her to work on.

### **Extension from Your Viewpoint (offered by Staff and ELC members)**

- An ELC member had been a 4-H Camp volunteer this year. He stated camp was very well organized and a positive environment for everyone. He wrote letters to Spring Vasey and Meagan Dyer, 4-H Extension Agents, to let them know it had been a great week and well planned.
- ELC member reported Frederick County 4-Hers had participated in National Shooting and National Trap Shooting competitions and had done a great job. One individual placed second in National Shooting, and we had the National Junior Team at the National Trap Shooting event. Frederick County had members on the Virginia Horse Team which competed in Perry, GA, and placed as the National Horse Judging Team.
- ELC member reported that the Frederick County Fair had been a busy week, and participation was good. State Fair is coming up in Lexington.
- Mark Sutphin stated that we had two great Summer Interns this year; Ellie Vincent and Quinna Molden who are both attending Kansas State University. He also mentioned that Farm Service Agency had drought assistance program for farmers.

# What's Happening in Winchester and Frederick County

- Emily Roy mentioned a Community Partner Form is being developed.
- Need 4-H in the schools and flyers to promote 4-H and exhibiting items at the fair.
- Have handouts at World of Works.
- ELC Member stated there were two Comprehensive Plan meetings coming up regarding the Land Use Plan and possible developments for the western part of the county.

  - Kim Costa, Family Nutrition Program Assistant-EFNEP & SNAP-Ed., resigned. The position is funded by Federal SNAP grant. Funding won't be reposted until Fall 2025.

### - FY25 Budget Cycle

- We received the funds requested from the County and the City of Winchester for FY25; the State budget was flat for Extension Agency 229.
- An ELC member is working on setting up a meeting with VCE administration and ELC members to discuss budget and past hiring requests.

  - Had an educational booth at the Frederick County Fair.
  - Extension Spotlight Event: Mark has spoken to County Administration about a work session with the Board of Supervisors. He was given possible dates of October 9 or 23 or November 13. Keighley will take the dates to the committee to decide on a meeting date.
