## **Extension Leadership Council**

February 7, 2024

The Frederick County Extension Leadership Council (ELC) met on Wednesday, February 7, 2024, at Horizon Farm Credit, Winchester, VA. Heather McKay called the meeting to order at 12:24 p.m. She welcomed everyone to the meeting introducing the newest ELC member Allison White representing the Opequon District, and Board of Supervisor Liaison John Jewell. We went around introducing ourselves.

### **Approval of Minutes from Previous Meeting**

Kunduck Moon made a motion that the November 1, 2023 minutes be approved. Sharon Mauzy seconded the motion. The minutes were approved.

- ELC member informed us briefly of Farm Bureau's Ag in the Classroom program and about Reading Day on March 18 at Quarles Elementary School.

- Mark welcomed and introduced our two newest members to the ELC: Allison White and John Jewell.

### **State and Local Budget Updates**

- i. 2023 Situation Analysis: final review and submission

Once we have the reports from the other PD7 counties, we would share them, too. Brief discussion/clarifications were made on acreage decrease (had to use 5-year old data since new Census not available yet) and who the report will be shared with (State

and local government, County Administration, Board of Supervisors, and it will also be available on VCE's website).

- Emily Schulz is the new 4-H Agent in Warren County. Her position is still completely funded by Warren County.
